RATIONALE

TRIS Rating downgrades the company rating on TPC Power Holding PLC (TPCH) to "BB" from "BB+" and places CreditAlert with a "negative" implication on the company rating. These follow our same rating actions on the company rating on Thai Polycons PLC (TPOLY, rated "BB/Alert Negative"), its parent company.

The rating downgrade on TPOLY, which mirrors the group credit profile, comes after its tight liquidity coverage to meet near-term debt obligations. The CreditAlert with a "negative" implication follows TPOLY's announcement to convene a meeting of debenture holders to seek extension of the maturity of its debentures. The "negative" implication indicates the uncertain outcome of the meeting, and the risk of payment default if debenture holders fail to agree the maturity extension. The "negative" CreditAlert also reflects the possibility that TPOLY may not secure sufficient liquidity sources to meet other debt obligations.

We could further downgrade the rating on TPOLY if it is increasingly unlikely TPOLY is able to secure sufficient liquidity sources or refinance debts, and could lower the rating by multiple notches in an anticipated default scenario.

We could remove the CreditAlert if we have greater visibility on TPOLY's concrete measures to effectively address its weak liquidity position.

Based on TPCH's group status as a core subsidiary of TPOLY, the rating and outlook on TPCH will follow those on TPOLY.
